# **DISCUSSION ITEMS:**

- Paddling Event for JROTC John Minar is making the arrangements and Deb suggested that more food be found for these volunteers who give so much..
- Cutting for 2019 August Jack is looking to cut from 127 to Stone Gate Farms in preparation for the September Clean-up.
- Wild Apricot Benji put out the October kayak sign up for the board to try. It should be easy. Some have done it and it appears to work. There was some discussion on what the minimum content should be prior to the web site conversion to Wild Apricot. We should also meet with the Non-Profit Network to get their opinion and assistance.

- Next Newsletter The electronic version is due out prior to the August Paddle Clinic on the 18<sup>th</sup>. Articles are due to Deb on August 1. The next quarter's newsletter will come out prior to the Cleanup on August 15. Benji will write an article on "Buffer Strips" and Jack will have an article on the River clearing activity to date.
- Report on the June Trip John Minar noted that there seemed to be a poor turn out in spite of the good weather. The pictures of the rapids were excellent. It was noted that one person tipped over. There was discussion of how to increase attendance. It was suggested that we survey members and reach out to the Jackson Young Professionals.
